## ACRL Symposium on Intellectual Freedom

“Operation Intellectual Freedom: Librarians on the Front Line” will be the topic for the 23rd annual symposium of the Greater New York Chapter of ACRL. The symposium will take place on November 21, 2003 at Baruch College in New York.

The program will feature the following speakers (in order of Presentation): **Judith Krug**, Director, ALA Office for Intellectual Freedom; **Lee Strickland**, Visiting Professor at the University of Maryland and U.S. Senior Intelligence Service Officer; **Steven Carlotta**, Chief, Division Counsel for the NY Office of the FBI; **Siva Vaidhyanathan**, Assistant Professor, Department of Culture and Communication, NYU, author of *Copyrights and Copywrongs* and the forthcoming *The Anarchist in the Library*; and **Rick Karr** of National Public Radio.

Librarians have always been concerned with issues of censorship, patron confidentiality, and abridgment of readers' rights and opportunities. This program topic came about because of the concern of librarians regarding the Patriot Act and these other issues. Suddenly libraries and librarians are in the headlines! The current tension between national security and individual freedoms is complex and the symposium committee agreed that this was the optimum time to explore it as it relates to librarians and the responsibility to their jobs and their patrons.

This will make for a very exciting program because, as librarians, we represent all sides of issues in our collections and in our discussions, and on Friday, November 21st, we will do just that.

## Highlights of the ACRL National Conference April 7-10, 2003

Sixty-four scholarships were given to the 2003 conference this year through the Friends of ACRL. The next conference will be in Minneapolis, April 7-10, 2005. This fall there will be a call for proposals. We want to get people involved. We also want proposals that speak to all aspects of the profession. Proposals are needed that are concerned with technical services and the computer support side of the profession, along with a variety of programming.

The following information was shared vis-a-vis advocacy. A letter was sent for administrators to have peer-to-peer file sharing. They have been working with the media industry on the question of music downloads. Mention was made about a white paper against publishing mergers. There have been face-to-face meetings about ERIC. It was reported that there were 2200 letters of protest received about the ERIC reorganization.

Mary-Ellen Davis spoke at her Provost's Dinner and covered topics such as copyright, the Patriot Act, and scholarly communications. Speaking at events such as these raise awareness of the profession. We need more visibility in the media, mention was made of the library media kit on the ALA website. Chapter members should be encouraged to join ACRL. A video is being shot at the conference to encourage recruitment. Spectrum scholars are being provided with an academic librarian mentor. The Investment Task Force is looking at effective use of funds. There will be a First Year Experience workshop for teaching faculty of incoming undergraduates and librarians. Also there should be a local effort to make sure that state organization and chapters are subscribed to the ALA chapters council listserv.
